## 1. Purposes and Arrangement of Exhibits

The purpose of the exhibits is to provide conference participants an opportunity to become aware of and to become knowledgeable about current and future technology, instrumentation, software, and technical and educational literature related to the general area of automatic control. If the Exhibitor cancels participation in the Exhibits Program, such cancellation shall be considered a default on the Exhibitor's part and monies paid shall be retained by the Management as liquidated damages.
